  - A limited number of vendors with similar menu items will be allowed.
  - Spots will be filled with another vendor if payment is not received in full by **June 28th, 2024**. No refunds will be given if canceled on or after July 1<sup>st</sup>, 2024.
  - Each vendor must be in compliance with the rules set by the Northeast Colorado Health Department.
